### 1. INTRODUCTION

The Town of Bradley (hereinafter referred to as "Town") is seeking to obtain proposals from qualified and eligible financial institutions to provide a lease purchase agreement for the purchase of one (1) Rosenbauer 3000-gallon tanker fire apparatus (hereinafter referred to as "Truck").

## 2. GENERAL INFORMATION

The Town of Bradley completed a request for bids for a fire apparatus/tanker in September of 2021. The bids were due on November 4, 2021. A total of nine (9) bids were received. The Bradley Volunteer Fire Department, with the approval of the Bradley Town Council, accepted the bid from Specialty Vehicles Inc. The chassis has been manufactured and is expected to be delivered by October 3, 2022 (though not guaranteed). The Town intends to pay for the chassis upon delivery to obtain a cost discount, however will be using this financing to replace those funds.
